LEGO Brand Group now holds a stake in innovative additive manufacturing company, U.S.-based Evolve Additive Solutions, which has created multiple applications for 3D printing in manufacturing. Additive manufacturing has been used by the LEGO Group for a number of years to create more agile, cost-efficient production options. Evolve's technology allows high-quality parts to be printed using similar materials to the current portfolio as well as explore sustainable alternatives.

LEGO Brand Group will also take a stake in Swedish-based Peppy Pals, one of the first companies to create playful digital experiences designed to equip, strengthen and nurture children's social and emotional skills. Peppy Pals has earned a strong reputation amongst educators and parents for its unique, research-based and engaging content.

In addition, LEGO Brand Group completed an investment in the Silicon Valley based venture firm, Innovation Endeavors, early in 2018. This is aimed at giving the Group access to emerging technology and new ventures, which may have long-term potential for the LEGO brand.

Jørgen Vig Knudstorp, Executive Chairman of LEGO Brand Group, said:

"The LEGO Brand Group's purpose is to enable continued, active and engaged family ownership of the different LEGO entities and to protect, develop and leverage the full potential of the LEGO brand. We are doing that primarily through the boards of the LEGO entities, but are also excited about exploring new ventures, which potentially can support the LEGO brand in the very long term."

Jørgen Vig Knudstorp continues:

"We fundamentally believe that the essential LEGO idea, which is about seeing the world with childlike curiosity, seeing children as our role models and the endless creative play with LEGO bricks, is more relevant than ever. We also believe that the LEGO idea can be used for far more than we can presently imagine and our engagement with Evolve, Peppy Pals and Innovation Endeavors is the very first step in exploring new ventures."
